## **Message from the HOA President**

Greetings Neighbors,

I wish to extend a heartfelt thank you to the Sixth Avenue West community for the effort and resources that you put into your properties. I like to think of the street presentation of our homes as a gift to the community. In this respect, you have generously given.

We have received occasional yard care complaints. For the most part, the owners are responsive. Sometimes we learn

of particular challenges that put yard care on the back burner.

I find that it is generally a kind gesture to reach out to neighbors to understand their situations. At times, the county has helped the board navigate these issues. We have no covenants that deal with yard presentation, but the county does have nuisance ordinances that govern weed and waste.

Sarah McAfee, the Foothills Parks and Rec Parks Operations Coordinator, led the effort to clean up the drainage along upper Flora at Maple and Cedar on September 23<sup>rd</sup>. The early summer rainstorm overwhelmed the drainage and brought debris that blocked the culverts and sent water over the roads. Sarah brought volunteers from the Church of Jesus Christ of Latter-Day Saints to help.

Foothills Parks and Rec owns and cares for nearly 50 acres of open space in Sixth Avenue West. We have many homeowners who take responsibility for adjacent open space areas. Thank you. Consider taking a trash bag to collect litter you may encounter on your neighborhood or Green Mountain walks. Also, consider pulling a few weeds along the way. You also have permission to remove any vendor signs on open space property or utility poles.

Again, thank you for doing your part to make the neighborhood look so nice.

# **Holeman Loop Long-Term RV Parking and Storage**

The excerpt below reflects many comments the board receives:

I am writing in regards to South Holman and the lack of a sidewalk that presents a safety issue. Who enforces the parking there and if there has ever been any consideration for putting in a sidewalk that goes around Amberwick, completing the loop from Flora. It has been a safety concern for so many years. It becomes more unsafe with everyone parking their extra vehicles on the road as well, leading to several blind spots. Can you please tell me how to or who to contact about the process of a sidewalk or eliminating street parking? I would love to see the loop around 6th avenue be totally walkable with sidewalks.

The way to get the ball rolling on this issue is to go to the website below. Jeffco Transportation and Engineering will assign an engineer to look at the problem. You will receive a confirmation # and a return follow up. Let's see if we can enter enough concerns to encourage Jeffco to make this issue an important priority. The board has and continues to talk to Amberwick about the lack of a sidewalk and on-site parking on their property.

#### Senate Bill 23-213 Fails to Pass

Senate Bill 23-213 Failed to pass this year. This bill would take away local voice in shaping our community. It would have replaced locally-sensitive city planning with top-down, one-size-fits-all state zoning and land use standards.

## **Proposition HH**

You will vote on this proposition in November. It changes TABOR as we know it. The bill proposes to lower property taxes in lieu of the State retaining future Tabor refunds. The measure removes important taxpayer protections and gives the state legislature the power to extend the new revenue cap forever without asking voters.
